Cook County Releases First Long-Range Transportation Plan in 75 Years

On July 13, Cook County Board President Toni Preckwinkle unveiled the county's 2040 long range transportation plan entitled "Connecting Cook County". The document is the county's first long-range plan in more than 75 years and will guide spending priorities over the next 25 years. The plan discusses the county's transportation needs, the current state of its transportation system and five policy priorities including:

- Prioritizing transit and other transportation alternatives
- Supporting the region's role as America's freight capital
- Maintaining and modernizing what already exists

- Promoting equal access to opportunities
- Increasing investments in transportation

The planning process, held over the course of the last two years, has involved several key stakeholders from agencies and municipalities throughout the county, including Northwest Municipal Conference appointee and *Northbrook Village President Sandy Frum*. CMAP 2050 Priorities Report Out For Comment


Following the first round of public engagement, the Chicago Metropolitan Agency for Planning (CMAP) has released a summary document (available here) of the key regional priorities that will shape their next regional comprehensive plan entitled On To 2050. In addition to existing Go To 2040 priorities which will continue or be refined in the new plan, topics such as stormwater and climate resilience, inclusive growth, shared services, asset management and transit modernization will be explored. CMAP plans to publish a se-

ries of snapshots and strategy papers on these topics in the coming year.

Comments can be submitted until 4:00 p.m. on Monday, August 15 by emailing onto 2050@cmap.illinois.gov with subject of "ON TO 2050 Priorities Comment." Additional opportunities for public engagement will start again in summer 2017, when CMAP will conduct extensive engagement on a series of alternative future scenarios for the region.

Start Planning Now for CMAQ and TAP funding

In early 2017, CMAP is planning to issue a call for new projects for the Congestion Mitigation and Air Quality Improvement (CMAQ) program and the Transportation Alternatives Program (TAP). Both programs require that Phase I design approval must be given by IDOT before any project can receive funding. This means a project should receive or be close to receiving design approval by June, 2017.

If your municipality has any potential projects for either program, please contact your Council's Planning Liaison soon to set up a meeting with IDOT to scope the project and determine how long the design approval process will take. Environmental clearances on projects which involve state right-of way can take between six months to one year, so planning now will put your project in a better position when applications are officially released.



Northwest Council of Mayors Update

The Northwest Council of Mayors Technical Committee will meet on Thursday, August 11 at 8:30 a.m. at *Barrington Village Hall*. In addition to program changes, the committee will consider whether to limit new applications to official "call for projects", or to

continue to allow new applications throughout the year with a one year waiting period before funds can be programmed. This is a follow-up of the discussion from the May Technical Committee meeting.



RTA Seeking Access to Transit Projects

The Regional Transportation Authority (RTA) has released a call for projects for the Access to Transit Improvement Program. The program is open to applicants that have completed (or are in the process of completing) a study through the RTA's Community Planning program or CMAP'S Local Technical Assistance (LTA) program.

The Access to Transit Improvement Program is intended to leverage RTA and local funds with federal Congestion Mitigation and Air Quality Improvement Program (CMAQ) funding to help implement small-scale projects that increase pedestrian and bicycle access to the transit system.

Applications are due to the RTA on or before Thursday, October 20. The long application period is intended to give applicants adequate time to initiate or complete the Phase I engineering aspect of the project.
