I. Call to Order

The Chair, President Darch called the meeting to order at 8:31 a.m.

II. Approval of Minutes

The minutes of the October 21, 2016 Technical Committee meeting were approved on a motion from President Hayes, seconded by Ms. Caddigan.

III. Agency Reports

a. CMAP

Mr. Elam and Mr. Kotarac gave the committee a presentation on the ongoing discussions to change the way STP funds are distributed in the region. They explained the history of the program and that the reasons why the formula is being reexamined: requirements of the new federal bill; CMAP's upcoming reauthorization; and, the need to renew the split agreement between the city and suburbs. Federal rules have more requirements for programming by performance measures and do not allow population based splits like the one currently used by CMAP and the councils. CMAP, IDOT, the councils, the City of Chicago and the FHWA have been meeting to determine a new method of distributing funds that meets the needs of the region while also meeting federal rules. The goal is to have a draft out this summer with the final adoption by October.

Mr. Norris asked if the autonomy of the councils would be impacted. Mr. Elam said not necessarily and that the group is looking at different options including keeping the current council system. Mr. Norris also asked whether local splits would be reduced. Mr. Kotarac responded not necessarily, since the overall pot of funding is getting larger. The council overall favored retaining programming by the local councils and expressed concerns whether the new system could be in place by October.

For the regular CMAP report, Mr. Elam reported that CMAQ obligations are behind, but STP obligations have been increasing; gave a series of upcoming calls for projects; and, reported that legislation repealing the MPO consolidation rules has been signed.

b. CMAP Council of Mayors Executive Committee

No report.

c. IDOT Highways

Mr. Farmer introduced himself covered changes on the status sheets, including those MYP projects that have moved up a year. Projects on the April letting in the area included US 14 at Broadway and crack and seal work on Route 53.

d. IDOT Local Roads

Mr. Fierro distributed project update sheets and noted the changes since the last meeting.

e. Cook County Department of Transportation and Highways.

Mr. Schmitz updated the committee on county projects in the council area, including Central at Roselle, Lake-Cook Road intersection improvements, and the Touhy Avenue underpass. Mr. Norris asked about work on Central Road in anticipation for the new ramp onto the Tollway. Mr. Schmitz responded that he would have the appropriate department staff follow up with answers.

f. Metra

Mr. Mack reported on that public comments received on Metra's fare structure will be presented to their board, with a decision on whether to change the structure likely to come later this year. He also reported the number of station agents are being reduced due to use of the Ventra app. President Darch asked for more outreach on early morning engine noise. Mr. Cassady asked for an update on renovations to the Mount Prospect station.

g. Pace

Mr. Andrews gave an update on the Pulse Milwaukee line, with construction coming this summer and service starting by the end of the year. On the Pulse Dempster line, Mr. Andrews reported that the environmental review has just started with public outreach coming soon. Pace is targeting construction in 2019, but the project is not yet fully funded. He also reported on growing ridership on the I-90 express service which started in December.

IV. NW Council FY 17-20 Surface Transportation Program

a. Current Program Update

Mr. Walczak presented the current program, noting the changes in project status since the last meeting. The committee discussed the mechanics of advanced funding. Mr. Walczak explained that if the council is projected to need advanced funding for the August and/or September lettings, he would prepare a letter for the Council of Mayors Executive Committee for President Darch to sign. The funds needed over the council's programming mark would then be subtracted from the following year's mark.

b. Project Updates

Niles – Milwaukee Avenue and Waukegan Avenue lighting

Mr. Vinezeano gave background on the need for the projects, stressing the safety aspects of the improvements, the age of the current system, the overall improvements made in the corridors. The village has also expended its own funding for engineering to move the project forward.

The committee discussed moving the project into the program while already over-programmed in 2018. Mr. Norris noted that he wants STP funds to be used primarily for roads, but the project did score well and Niles has not had many projects recently. Mr. Ottesen asked about other grant opportunities that the

village had pursued. Mr. Rummel thanked Mr. Vinezeano for coming and voiced his support based on securing advanced funding. Mr. Ottesen also requested future updates on the status of the project.

The project was moved from the MYB list to FY 2018 pending approval of advanced funding from the full Council of Mayors, on a motion from Mr. Norris, seconded by Mr. Rummel.

c. Call for New Projects Discussion

Based on the uncertainty with the earlier STP funding discussion, the committee agreed to wait to discuss a new call for projects until the next meeting.

d. Approval of Updated Program

The updated program was approved on a motion by President Hayes, seconded by Mr. Rummel.

V. Other Business

There was no other business.

VI. Next Meeting

The next meeting was left on call for after the release of the draft STP distribution proposal.

VII. Adjourn

The meeting was adjourned at 9:20 a.m. on a motion from Mr. Cassady, seconded by Ms. Caddigan.

Customer satisfaction up in latest survey

Nearly all measures increase since 2014 survey

CHICAGO (June 26, 2017) – Eighty-three percent of Metra customers are satisfied with Metra overall and nearly 90 percent of customers are likely to recommend Metra to others, according to the results of the 2016 customer satisfaction survey. The overall satisfaction score is eight percentage points better than the last survey in 2014, and Metra also showed improvement in most every other measure included in the survey.

“We have been working as hard as we can to provide safe, reliable and comfortable service and we are extremely gratified that those efforts are reflected in an increase in customer satisfaction,” said Metra Executive Director/CEO Don Orseno. “Since the last survey in 2014, Metra has added passenger amenities such as the Ventra App, an upgraded website, more outlets on trains, charging stations at stations and installation of Wi-Fi on 62 railcars, and has been on a 27-month streak of meeting or exceeding its on-time performance goal. Customers have clearly taken notice.”

For instance, 95 percent of respondents said they were satisfied with the ease of ticket purchase, an increase of 25 percentage points from 2014. That jump is likely attributable to the introduction in late 2015 of the Ventra App and mobile ticketing, which has become hugely popular with Metra customers. Today a third of all Metra tickets are sold via the Ventra App.

The results reflect the opinions of 9,711 customers who answered questions in the online survey last fall. The survey effort was sponsored by the RTA, which oversaw the interaction with the contractor and aided in the development of the surveys’ design, administration and coordination with Metra, CTA and Pace.

Survey respondents said they were satisfied with;

- How safely the train is operated (96 percent)
- Personal safety onboard the train (96 percent)
- Personal safety at stations (94 percent)
- The knowledge of Metra employees onboard trains (92 percent)
- The knowledge of Metra employees at stations (89 percent)
- The availability of schedule/route information (89 percent)
- The courtesy of onboard personnel (88 percent)

- The courtesy of station personnel (86 percent).
- Cleanliness of stations (86 percent)
- Cleanliness of boarding station (85 percent)
- Clarity of station signage (84 percent),
- Cleanliness onboard trains (79 percent)
- The total travel time of their trip (78 percent)
- Availability of information at metrarail.com (78 percent)
- The number of scheduled trains in rush hour (76 percent)
- Getting to their destination on time (75 percent)
- Onboard announcement of stations while riding (72 percent).
- The value of service for fare paid (71 percent).

Of the top six service attributes that determine overall satisfaction, Metra is meeting respondents' expectations in total travel time, onboard personnel courtesy and safe train operation but has more work to do on getting to destination on time, notification of service changes and availability of transit in the region, according to the survey.

Metra to purchase new, modern seats

Customer feedback results in additional design enhancements

CHICAGO (June 21, 2017) – After a yearlong pilot program to test a new style of seats with armrests, built-in cup holders and better head, neck and lumbar support, Metra today announced plans to purchase and install the new, modern seats on an ongoing basis as it rehabilitates its fleet of railcars. The new seats will also be included in future railcar purchases and will become the standard for Metra’s fleet moving forward.

As part of the pilot program, Metra used a survey to gather input from customers about what they liked and didn’t like about the new seats and the older seats. While the new seats were not favored by everyone, Metra believes there are strong economic reasons for choosing the new style and the design will be further enhanced based on the feedback received from customers.

“This was not an easy choice to make because we know that many of our customers like the older, bench-style seats,” said Metra Executive Director/CEO Don Orseno. “But we received some great input from our customers that we will incorporate into the next design that will make the new seats even more comfortable.”

Survey respondents who had an opinion about the headrests and armrests on the older seats indicated that they were unsatisfied with these features. The armrests on the new seats fared better, but customers requested that an armrest be added to the seats on the aisle. As a result, the additional armrest will be added to the new seat design.

The majority of respondents who had an opinion about the new seats agreed that the seats were easy to get in and out of and that they were attractive. However, Metra received some comments stating that the aisles were too narrow. Therefore, the seats will be modified slightly to widen the aisles to their original width.

The survey responses indicated that the cup holders were useful, but some respondents indicated that they were too small to hold a large-sized drink. In response, the new design will feature enlarged cup holders.

Most respondents indicated they were unsatisfied with the direction the new seats face (the stationary design means that half of seats face backwards), however, the majority of customers who had an opinion about the new seats were satisfied with both their comfort and size.

In addition, Metra will continue to install USB ports and power outlets in its railcars to allow customers to charge their phones and mobile devices while onboard.

The new seats cost about the same as the older seats, but there are more manufacturers of this style in the rail industry, which is expected to keep the prices competitive and drive down future procurement costs. Further, replacing the new seats in future rehabilitations will cost about 50 percent less than replacing the old ones because parts can be reused.

Metra is not spending any extra money on the new seats; they are being installed in cars whose seats need replacement anyway, and rather than replace them with the older style the agency is replacing them with the new style. The agency also hopes that the new, stationary design will help prevent injuries to customers and employees who pinch their fingers and strain muscles flipping the older seats back and forth.

“The reality is that these new seats have become the standard for the vast majority of commuter railroads,” Orseno added. “We are excited to take this step forward with railcars that feature a more modern seat design.”
