The General Assembly has scheduled their annual fall Veto Session for Tuesday, November 15 – Thursday, November 17 and Tuesday, November 29 – Thursday, December 1. Staff will report on potential issues under consideration.

**3. Allowing Drones for Law Enforcement (Attachment E)**

Current state law prohibits police departments from proactively using drone technology to provide security during community special events such as parades. House Bill 5452 would make changes to the Illinois Freedom from Drone Surveillance Act to allow their use during these events. This issue could be under consideration during veto session. The Executive Board recommends support.
