TO: North Shore Council of Mayors

RE: Local Surface Transportation Program – 2022 Call for Projects
DATE: November 18, 2021

The North Shore Council of Mayors will open their Call for Projects for Local Surface Transportation Program (STP-L) funding on January 17, 2022. Below is a schedule of major milestones:

- **January 6, 2022, 10:00 a.m. - 11:00 a.m.** – Call for Projects Workshop (to be held virtually via Zoom)
- **January 17, 2022** – Call for Projects opens
- **March 18, 2022, 5:00 p.m.** – Call for Projects closes
- **April 14, 2022** – Preliminary program sent to North Shore Council of Mayors Technical Committee for review
- **April 21, 2022** – North Shore Council of Mayors Technical Committee reviews preliminary program and releases for 30 day public comment
- **April 25, 2022** – Public comment opens
- **May 26, 2022** – Public comment closes
- **July 21, 2022** – Public comments and final recommended program presented to North Shore Council of Mayors Technical Committee for approval
- **September 14, 2022** – Final recommended program presented to full North Shore Council of Mayors for approval

Final programs will be presented to the CMAP Transportation Committee at their September 2022 meeting and approved by the CMAP Board and MPO Policy Committee in October.
